**Colorado Department of Higher Education announces appointees for
Sexual Misconduct Advisory Committee**

*Committee will make recommendations for processes that align with
forthcoming federal Title IX rule changes*

DENVER, Dec. 23, 2019: Dr. Angie Paccione, executive director of the Colorado Department of Higher Education (CDHE), appointed 11 members to Colorado's Sexual Misconduct Advisory Committee that will advise higher education leaders and policymakers on forthcoming federal rule changes to Title IX.

Among several provisions, Senate Bill 19-007 directs CDHE to establish a committee comprised of Title IX coordinators at higher education institutions, care providers, advocates and attorneys who represent both survivors and those accused of sexual misconduct. The committee will publish a report of their recommendations and prevention strategies on campuses by January 2021. Committee documents will be [posted on the CDHE website](#).

"The Colorado Department of Higher Education is committed to fostering safe learning environments free of gender-based discrimination, violence and harassment," said Dr. Paccione. "Our appointees bring a wealth of experience and expertise to this committee, and we look forward to establishing consistent, research-based practices that we can implement statewide."
